- Custom made fly rods by Ed Zebrowski, Jr., Owner Bear Creek Custom Rods
- Ross "Evolution" 5/6 wt. reels with Rio fly line
- Breathable rain coats
- Custom tied flies
- Three course streamside cooked dinner: Appetizer Chilled Shrimp, Grilled Buffalo, Potato Salad, Strawberry Shortcake with real whipped cream, snacks and soda.
- Extra hats, jackets, sun glasses, Kleenex, and a first aid kit.

Personal Recommendations:

- Please pack very light, it will leave more floor space for you to cast from.
- Take your time and drive safely. If you are late, don't worry, we can start later.
- Keep any valuable items in the car as they may get wet.
- Eat a good meal before your fishing trip begins.
- Try not to hook the guide!

Fishing and Safety Regulations:

- **Catch and release fishing only- NO EXEPTIONS**, unless of course it's a Mermaid (Hey, I'm single)

For Insurance Reasons:

- No alcohol
- No tobacco of any kind
- Children 10 and older only
- All passengers including myself must wear a small CO2 life belt or unrestricing life vest
- Please note once the float trip starts you will be approximately 8 hours away from the nearest hospital

Weather Conditions:

- Don't cancel your trip due to weather, light rain is great for fishing.
- If a major thunder/rainstorm occurs and we cannot fish safely, you will be rescheduled for free
- In July & August you can wade wet, i.e. bathing suit and water shoes

Don't Forget:

- Fishing license & trout stamp
- Polarized sunglasses
- Waders
- Medications
- Sun block
- Please do not bring glass containers; it is prohibited by the U.S.F.S.

Cancellation Policy: 7 day notice- Full Refund, 3 day notice- 50% Refund, Less than 3 days no refund unless I am able to rebook with a different client.

Deposit: Half of the trip amount is required to hold your reservation; full balance is due after trip.

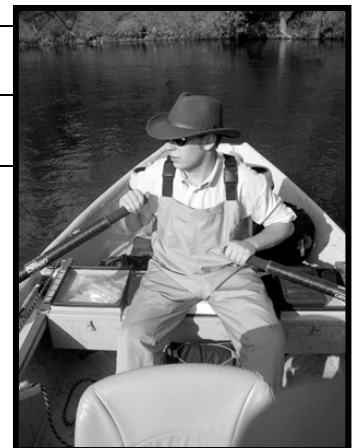

RELEASE AND WAIVER OF LIABILITY AGREEMENT

1. Rules and Conditions of Service: The client shall comply with the following rules and conditions of Michael A. Johnson River Guide, LLC as a prerequisite to the performance of the service.

- 1.1 The client agrees to catch and release fishing only.
- 1.2 The client shall refrain from use of tobacco products of any kind in the boat.
- 1.3 No alcohol shall be allowed during the service provided by Michael A. Johnson River Guide, LLC.
- 1.4 The client shall not be intoxicated during the fishing trip
- 1.5 Only persons weighing **285 lbs.** and under shall use the pedestal seats provided by Michael A. Johnson River Guide, LLC.
- 1.6 The client agrees not to bring glass containers on the river.
- 1.7 The client agrees to wear glasses for eye protection.
- 1.8 The client agrees to wear small CO2 belt inflatable life jacket.

Failure to abide by the terms of these Rules and Conditions of Service shall be grounds for Michael A. Johnson River Guide, LLC to terminate your river guide services and retain 100% of the fee for same as liquidated damages.

2. Release, Waiver, and Indemnification: For good and valuable consideration, including payment for river guide services, the client for themselves and their agents, representatives, heirs, administrators, successors, and assigns, waives liability for releases and forever discharges Michael A. Johnson River Guide, LLC, its agents, partners, affiliates, successors, and assigns of all causes of actions, whether known or unknown that the client may have against it arising out of the river guide services that Michael A. Johnson River Guide, LLC is providing to client contemporaneous with the execution of this document.

- 2.1 **Inherent Danger:** The parties acknowledge that fishing in a boat is an inherently dangerous activity that is being conducted on a river or lake, where cell phones and other means of communication are not always available. The nearest hospital is sometimes over 8 hours away from the location of the boat. Knowing the same, the client releases and forever waives any claim against Michael A. Johnson River Guide, LLC, as set forth above.
- 2.2 **Indemnification:** Client agrees to indemnify, defend and hold harmless Michael A. Johnson River Guide, LLC, against any and all claims, damages, losses, and expenses (including but not limited to, reasonable attorney's fees) threatened, asserted, or filed by the client or a third party arising out of or relating to (i) client's use of the river guide services, (ii) any breach by client of this agreement, or (iii) and acts or omissions of client. The terms of this section will survive any termination of this agreement.
